<u>8.01</u> WARREN COUNTY ELECTION PRECINCTS.

The election precincts for Warren County are established as follows:

Precinct Names and Boundaries.

- Allen 2. This Precinct shall consist of the portion of the City of Carlisle located in Warren County, Iowa lying east of Southeast 52nd Street and north of a boundary described as follows: Beginning at the intersection of Highway 5 and the corporate limits of the City; thence southeast on Highway 5 to Northeast 21st Street; thence northeast to the frontage road; thence southeast to School Street, thence east on School Street to the corporate limits.
- 2. Allen 3. This Precinct shall consist of the remaining portions of the City of Carlisle located in Warren County, Iowa, that are not included in Allen 2 and all of unincorporated Allen township in Warren County except the territory all lying west of a line described as beginning at the intersection of 135th Avenue and the Polk/Warren County line; thence south to Beardsley Street; thence east along Beardsley Street to 140th Avenue; thence south along 140th Avenue to the North River; thence westerly along the North river to the south corporate limits of the City of Des Moines and the west boundary of Allen Township.
- 3. Belmont. This Precinct shall consist of all of Belmont Township.
- 4. Cumming/West Des Moines. Beginning at the intersection of County Line Road and 40th Ave; thence south on 40th Ave to the South Corporate limits of Cumming; thence following said corporate limits westerly to Warren Ave; thence north to County Line Road; thence east along County Line Road to the point of beginning.

- 5. Des Moines 73 (formerly known as Greenfield 1 DM85). Beginning at the intersection of East County Line Road and south corporate limits line of the City of Des Moines and 135th Ave; thence south along the corporate limits line of the City of Des Moines and 135th Ave to Beardsley St; thence east along Beardsley Street to 140th Ave; thence south along 140th Avenue to the North River; thence westerly along the North River to south corporate limits of the City of Des Moines; thence clockwise and counterclockwise along said south corporate limits to U.S. Highway 65/69; thence southeasterly along U.S. Highway 65/69 and south corporate limits of the City of Des Moines to the North River; thence northwesterly along the North River and said south corporate limits line of the City of Des Moines to East Border Street; thence west along East Border Street and said south corporate limits line of the City of Des Moines; and continuing west along Beardsley Street to its intersection with the south corporate limits line of the City of Des Moines; thence north along said south corporate limits to the northwesterly right of way line of Iowa Highway 5; thence westerly and northwesterly along the south corporate limits line of the City of Des Moines and the northwesterly right of way line of Iowa Highway 5 to 100th Ave; thence east along East County Line Road to its intersection with 135th Avenue and the south corporate limits line of the City of Des Moines, the point of beginning.
- 6. Des Moines 74 (formerly known as Greenfield 1 DM 86). Beginning at the intersection of County Line Road and 100th Avenue; thence south along 100th Avenue following the corporate limits of the City of Des Moines southerly and easterly to Iowa Highway 5 and the corporate limits of the City of Des Moines; thence following said corporate limits clockwise to the intersection of said corporate limits with Blue Street; thence west along Blue Street to the intersection of Blue Street and the corporate limits of the City of Des Moines; thence west on Blue Street to the intersection of Blue Street along said corporate limits to the intersection of Blue Street limits; thence west on Blue Street to 85th Avenue; thence north on 85th Ave to Beardsley Street; thence west on Blue Street to 80th Ave and the City of Norwalk Corporate Limits; thence north, southwest, north, west, and north following the corporate limits of the City of Norwalk to County Line Road; thence east along the western extension of County Line Road and along County Line Road to the intersection with 100th Avenue, the point of beginning.
- 7. Greenfield 1 (W ¹/₂ Greenfield). This Precinct shall consist of Greenfield township lying west of a line descried as beginning at the intersection of R63 Highway and the southern boundary of Greenfield township; thence north along R63 Highway to the southwest corner of census block 191810203001035; thence north along the western boundary of said census block to the southwest corner if census block 191810203001030; thence north along the western boundary of said census block to the southwest corner if census block to the southwest corner of census block 191810203001029; thence continuing north and west along the western boundary of said census block to the southwest corner of census block 191810203001018, also being the intersection with the south corporate limits of the City of Des Moines, including the city of Spring Hill.

- 8. **Greenfield 2** (E ¹/₂ **Greenfield**). This Precinct shall consist of those portions of Greenfield township not included in the Greenfield 1 Precinct.
- 9. **Jackson**. This Precinct shall consist of all of Jackson Township, including the City of St. Marys.
- 10. **Jefferson**. This Precinct shall consist of all of Jefferson Township, including the City of Martensdale and that portion of the City of Bevington lying within Warren County.
- 11. Liberty. This Precinct shall consist of all of Liberty Township.
- 12. Lincoln 1 (West Lincoln and W 1/2 East Lincoln). This Precinct shall consist of all of West Lincoln Township except that part of West Lincoln Township described in Indianola Precinct 5; and part of East Lincoln Township lying west of line described as beginning at the intersection of Summerset Road and U.S. Highway 65/69; thence east along Summerset Road to the intersection of Summerset Road and 150th Avenue; thence south along 150th Avenue to the intersection of 150th Ave and G36 Highway; thence south along G36 Highway to the intersection of 150th Avenue and Illinois Street; thence east along Illinois Street to the intersection of 150th Avenue and Highway 92; thence west along 165th Avenue to the intersection of 165th Avenue and Highway 92; thence west along Highway 92 to the intersection of 160th Avenue and Kennedy Street; thence south along 160th Avenue to the intersection of Street and 150th Avenue; thence south along 160th Avenue to the intersection of Highway 92 and 160th Avenue; thence south along 160th Avenue to the intersection of 160th Avenue and Kennedy Street; thence south along 160th Avenue to the intersection of Kennedy Street and 150th Avenue; thence south along 160th Avenue to the intersection of Kennedy Street and 150th Avenue; thence west along Kennedy Street to the intersection of Kennedy Street and 150th Avenue; thence west along Kennedy Street to the intersection of Kennedy Street and 150th Avenue; thence west along Kennedy Street to the intersection of Kennedy Street and 150th Avenue; thence west along Kennedy Street to the intersection of Kennedy Street and 150th Avenue; thence west along 150th Avenue to the intersection of Kennedy Street and 150th Avenue; thence west along Street to the intersection of Kennedy Street and 150th Avenue; thence west along 150th Avenue to the south boundary of East Lincoln Township.
- 13. Lincoln 2 (East 1/2 East Lincoln). This Precinct shall consist of East Lincoln Township lying east of line described as beginning at the intersection of Summerset Road and U.S. Highway 65/69; thence east along Summerset Road to the intersection of Summerset Road and 150th Avenue; thence south along 150th Avenue to the intersection of 150th Ave and G36 Highway; thence south along G36 Highway to the intersection of 150th Ave and G36 Highway; thence south along 150th Avenue to the intersection of 150th Avenue and Illinois Street; thence east along Illinois Street to the intersection of 165th Avenue and Highway 92; thence west along Highway 92 to the intersection of 165th Avenue and Highway 92; thence west along 160th Avenue to the intersection of 160th Avenue and Kennedy Street; thence west along Street to the intersection of 160th Avenue and 150th Avenue; thence south along 160th Avenue to the intersection of 160th Avenue and 150th Avenue; thence south along 160th Avenue to the intersection of 160th Avenue and Highway 92; thence west along Highway 92 to the intersection of 160th Avenue and Kennedy Street; thence west along 160th Avenue to the intersection of 160th Avenue and Kennedy Street; thence west along Kennedy Street to the intersection of Kennedy Street and 150th Avenue; thence south along 150th Avenue to the south boundary of East Lincoln Township; and the City of Ackworth.
- 14. **Linn**. This Precinct shall consist of those portions of Linn township not included in the Cumming/West Des Moines Precinct.
- 15. Otter. This Precinct shall consist of all of Otter Township, including the City of Milo.

- 16. Palmyra. This Precinct shall consist of all of Palmyra Township.
- 17. **Richland**. This Precinct shall consist of all of Richland Township, including the City of Hartford.
- 18. Squaw Creek. This Precinct shall consist of all of Squaw Creek Township.
- 19. **Union**. This Precinct shall consist of all of Union Township, including the City of Sandyville.
- 20. **Virginia**. This Precinct shall consist of all of Virginia Township, including the City of New Virginia.
- 21. White Breast. This Precinct shall consist of all of White Breast Township including the City of Lacona.
- 22. White Oak. This Precinct shall consist of all of White Oak Township.

<u>8.02</u> CITY OF INDIANOLA. (City Ordinance 3.01).

The City is hereby divided into four wards by drawing two imaginary lines, as follows:

One line, which is basically a north-south line, shall begin at the intersection of the centerline of North Jefferson Way and the north corporate limits and shall proceed thence south along the centerline of North Jefferson Way to the centerline of East Girard Avenue, thence west along the centerline of East and West Girard Avenue to the centerline of North D Street, thence south along the centerline of North D Street to the centerline of West 2nd Avenue, thence west along the centerline of West 2nd Avenue to the centerline of South Freeman Street, thence south along the centerline of South Freeman Street to the centerline of West 4th Avenue, thence west along the centerline of West 4th Avenue to the centerline of South G Street, thence south along the centerline of South G Street to the centerline of West 12th Street, thence west along the centerline of West 12th Street to the centerline of South K Street to the centerline of South K Street to the intersection with the south corporate limits.

The other line which is basically an east-west line beginning at the intersection of the centerline of East Iowa Avenue and the east corporate limits, thence west along East Iowa Avenue to the centerline of North 15th Street, thence south along the centerline of North 15th Street to the centerline of the McVay Trail, thence west along the centerline of the McVay Trail to the centerline of North 5th Street, thence south along the centerline of North 5th Street to the centerline of East Clinton Avenue, thence west along the centerline of East and West Clinton Avenue to the centerline of North J Street, thence north along the centerline of North J Street, to the centerline of West Euclid Avenue, thence west along the centerline of West Euclid Avenue to the centerline of North Y Street, thence north along the centerline of North Y Street to the

centerline of Inwood Street, thence west along the centerline of Inwood Street to the intersection with the west corporate limits.

The **First Ward** consists of all that part or portion of the City lying to the east of the north-south line and north of the east-west line, as described above. The First Ward is divided into two precincts by drawing an imaginary line that begins at the intersection of North Jefferson Way and East Hillcrest Avenue, thence east along the centerline of East Hillcrest Avenue to the centerline of North 9th Street, thence south along the centerline of North 9th Street to the east-west line, as described above.

The **Second Ward** consists of all that part or portion of the City lying to the west of the northsouth line and north of the east-west line, as described above. The Second Ward is divided into two precincts by drawing an imaginary line that begins at the intersection of Country Club Road with the north corporate limits, thence south along the centerline of Country Club Road to the centerline of West Iowa Avenue, thence west along the centerline of West Iowa Avenue to the intersection of North J Street, thence south along the centerline of North J Street to the intersection of West Euclid Avenue, thence west along the centerline of West Euclid Avenue to the east-west line, as described above.

The **Third Ward** consists of all that part or portion of the City lying to the south of the east-west line and west of the north-south line, as described above. The Third Ward is divided into two precincts by drawing an imaginary line that begins at the intersection of North Kenwood Boulevard and West Euclid Avenue, thence south along the centerline of North Kenwood Boulevard to the centerline of West 2nd Avenue, thence east along the centerline of West 2nd Avenue to the centerline of South G Street, thence south along the centerline of South G Street to the north-south line, as described above.

The **Fourth Ward** consists of all that part or portion of the City lying to the east of the northsouth line and south of the east-west line, as described above. The Fourth Ward is divided into two precincts by drawing an imaginary line that begins at the intersection of East Clinton Avenue and North Jefferson Way, thence south along North and South Jefferson Way to the centerline of East Plainview Avenue, thence east along the intersection of East Plainview Avenue to the east corporate limits.

Indianola Voting Precincts

There are eight voting precincts, numbered from 1 to 8, inclusive, which correspond and are coextensive with the limits of the respective wards established in City of Indianola Ordinances, Section 3.01.

Precinct 1 is located wholly within the First Ward, as described in Section 3.01(1), and is north and east of a line that begins at the intersection of North Jefferson Way and East Hillcrest Avenue, thence east along the centerline of East Hillcrest Avenue to the centerline of North 9th Street, thence south along the centerline of North 9th Street.

Precinct 2 is located wholly within the First Ward, as described in Section 3.01(1), and is south and west of a line that begins at the intersection of North Jefferson Way and East Hillcrest Avenue, thence east along the centerline of East Hillcrest Avenue to the centerline of North 9th Street, thence south along the centerline of North 9th Street.

Precinct 3 is located wholly within the Second Ward, as described in Section 3.01(2), and is east and south of a line that begins at the intersection of Country Club Road with the north corporate limits, thence south along the centerline of Country Club Road to the centerline of West Iowa Avenue, thence west along the centerline of West Iowa Avenue to the intersection of North J Street, thence south along the centerline of North J Street to the intersection of West Euclid Avenue, thence west along the centerline of West Euclid Avenue.

Precinct 4 is located wholly within the Second Ward, as described in Section 3.01(2), and is west and north of a line that begins at the intersection of Country Club Road with the north corporate limits, thence south along the centerline of Country Club Road to the centerline of West Iowa Avenue, thence west along the centerline of West Iowa Avenue to the intersection of North J Street, thence south along the centerline of North J Street to the intersection of West Euclid Avenue, thence west along the centerline of West Euclid Avenue.

Precinct 5 is located wholly within the Third Ward, as described in Section 3.01(3), and is west and south of an imaginary line that begins at the intersection of North Kenwood Boulevard and West Euclid Avenue, thence south along the centerline of North Kenwood Boulevard to the centerline of West 2nd Avenue, thence east along the centerline of West 2nd Avenue to the centerline of South G Street, thence south along the centerline of South G Street.

Precinct 6 is located wholly within the Third Ward, as described in Section 3.01(3), and is east and north of an imaginary line that begins at the intersection of North Kenwood Boulevard and West Euclid Avenue, thence south along the centerline of North Kenwood Boulevard to the centerline of West 2nd Avenue, thence east along the centerline of West 2nd Avenue to the centerline of South G Street, thence south along the centerline of South G Street.

Precinct 7 is located wholly within the Fourth Ward, as described in Section 3.01(4), and is west and south of an imaginary line that begins at the intersection of East Clinton Avenue and North Jefferson Way, thence south along North and South Jefferson Way to the centerline of East Plainview Avenue, thence east along the intersection of East Plainview Avenue to the east corporate limits.

Precinct 8 is located wholly within the Fourth Ward, as described in Section 3.01(4), and is east and north of an imaginary line that begins at the intersection of East Clinton Avenue and North Jefferson Way, thence south along North and South Jefferson Way to the centerline of East Plainview Avenue, thence east along the intersection of East Plainview Avenue to the east corporate limits.

8.03 CITY OF NORWALK.

The City is divided into seven (7) voting precincts described as follows:

Precinct 1 is comprised of territory located within the following area:

South of Beardsley Street from 50th Avenue (point of beginning) to Lexington Drive, west of Lexington Drive from Beardsley Street to Colonial Circle, west of Colonial Circle from Lexington Drive to Bristol Street, west of Bristol Street from Colonial Circle to High Road, north of High Road from Bristol Street to the east property line of 118 W High Road, west of a line from the east lot line of 118 W High Road to the intersection of North Avenue and Sycamore Drive, north and east of North Avenue/Highway G14 from Sycamore Drive to 50th Avenue, east of 50th Avenue from Highway G14 to Beardsley Street.

Precinct 2 is comprised of territory located within the following area:

East of Lexington Drive from Beardsley Street (point of beginning) to Colonial Circle, east of Colonial Circle from Lexington Drive to Bristol Street, east of Bristol Street from Colonial Circle to High Road, south of High Road from Bristol Street to the west property line of 114 W High Road, east of a line from the west property line of 114 W High Road to the intersection of North Avenue and Sycamore Drive, north of North Avenue from Sycamore Drive to Highway 28, west of Highway 28 from North Avenue to Beardsley Street, south of Beardsley Street, from Highway 28 to Lexington Drive.

Precinct 3 is comprised of territory located within the following area:

North of North Avenue from E 17th Street (point of beginning) to Highway 28, east of Highway 28 from North Avenue to Gordon Avenue, west of Cherry Parkway, and an extension north thereof, from Gordon Avenue to Richard George Drive, south of Richard George Drive from Cherry Parkway to Merle Huff Drive, south of Merle Huff Drive from Richard George Drive to the west property line of 1943 Merle Huff Drive, 1943 Merle Huff Drive, an area bound by city limits heading east from the north property line of 1943 Merle Huff Drive to the intersection of North Avenue and E 17th Street.

Precinct 4 is comprised of territory located within the following area:

All areas bound by city limits south of North Avenue.

Precinct 5 is comprised of territory located within the following area:

East of Highway 28 from the north city limits (point of beginning) to Gordon Avenue, east of Cherry Parkway, and an extension north thereof, from Gordon Avenue to Richard George Drive, north of Richard George Drive from Cherry Parkway to Merle Huff Drive, north of Merle Huff Drive from Richard George Drive to the west property line of 1943 Merle Huff Drive, an area

bound by city limits heading north from the north property line of 1943 Merle Huff Avenue to Highway 28.

Precinct 6 is comprised of territory located within the following area:

West of Highway 28 from the northern city limits (point of beginning) to Beardsley Street, north of Beardsley Street from Highway 28 to 50th Avenue, east of 50th Avenue from Beardsley Street to the northern city limits, south of the city limits from 50th Avenue to Highway 28.

Precinct 7 is comprised of territory located within the following area:

West of 50th Avenue from the northern city limits (point of beginning) to Highway G14, west of Highway G14 between 50th Avenue intersections, an area bound by city limits from the southern intersection of 50th Avenue heading west, north and east, to 50th Avenue.

<u>8.04</u> TOWNSHIP BOUNDARIES.

All township boundaries shall remain as prior fixed and each township shall retain its own elected officials. Boundary changes within a township are for election purposes only.

<u>8.05</u> <u>CITY OR TOWNSHIP ELECTIONS.</u>

Residents within established townships and incorporated cities shall continue to vote for their respective elected officials. There is no combination of townships or townships and cities for this purpose.

<u>8.06</u> AUTHORIZATION.

The Chairperson is authorized to sign the precinct population certification and the County Auditor is directed to forward the certification to the office of the Secretary of State.
