

Warren County Construction Projects as of 5/2/23

Bridge Replacement Project on Idaho St. Over Branch Middle River:

Warren County Bridge Replacement Project BROSCHBP-C091(134)- -NC-91 located on Idaho St. 0.3 miles West of 50th Ave. over Branch of Middle River. Construction is substantially complete. Idaho St. is open to traffic.

Bridge Replacement Project on S23 Hwy. near the South Corporation Line of Lacona Over Mill Creek:

Warren County Bridge Replacement Project BRS-CHBP-C091(133)- -GB-91 located on S23 Hwy. over Mill Creek near the South corporation line of Lacona. Project is substantially complete. S23 Hwy. is open to traffic.

City of Indianola WRRF Influent Trunk Sewer on Grimes St. and 110th Ave.:

Grimes St. and 110th Ave. are open to traffic. Please contact the City of Indianola with any concerns or questions.

FM Bridge Replacement Project on Stone Street (G64) Sec. 14, T74N – R25W:

Warren County Bridge Replacement Project FM-C091(138)- -55-91 on Stone Street (G64) over Branch of South River, 0.75 miles East of R45 Hwy. Project has been awarded to Herberger Construction Co. of Indianola, Iowa. A tentative start date of May 15th, 2023 has been set. A detour route will be established for this project, and the road will be closed to thru traffic. The anticipated closure time will be 3 months.

Local Bridge Replacement Project on Dubuque Street Sec. 28, T77N – R24W:

Warren County Bridge Replacement Project L-BrC2820- -73-91 on Dubuque St. over Branch of North River. Project is substantially complete, and Dubuque St. is open to traffic.

IDOT Bridge Replacement/Grade/Pave Project on Hoover St. Over I35:

IDOT will be replacing the Hoover St. Overpass Bridge of Interstate 35 and grade/pave a portion of I35. Construction is underway. 10th Ave. and 20th Ave. will be designated haul routes for this project. IDOT Bridge Deck Rehabilitation Projects on G50 and G64 Highways Over I35:

IDOT will be performing bridge deck rehabilitation projects on the overpass bridges of I35 on G50 and G64 Highways. G50 Hwy. is currently closed and under construction.
