## PUBLICATION NOTICE FOR SPECIAL ELECTION AUGUST 29, 2023

In accordance with the provisions of Chapter 49.53 Code of Iowa, I, David Whipple, Warren County Commissioner of Elections, do hereby proclaim and give notice of a Special Election on August 29, 2023, for Warren County Auditor Interim to fill a vacancy, to be held in Warren County, Iowa.

There will be twenty-two (22) polling locations located around Warren County that are listed below. We did combine precincts together for this Special Election. For those polling places that have changed, residents should have received a letter of notification listing their temporary polling location only for this Special Election. If you are unsure, please contact the Auditor's office at 515-961-1020. Polls are open from 7:00am to close at 8:00pm.

The candidates that will appear on the Special Election ballot are Kimberly Sheets for the Democratic seat and David Whipple for the Republican seat. The date to start filing the certificate of candidacy was July 11, 2023, and the deadline to file was August 4, 2023.

The pre-registration deadline for voters that are considering voting during this Special Election is August 14, 2023, according to 48A.9(1) of Iowa Code. If a voter is not registered before or on August 14, 2023, the voter will have to do an election day registration, which means the voter will have to show a form of a current, valid, photo ID, that contains an expiration date and proof of residency, see 48A.7A of Iowa Code.

Voters may call the Auditor's office at 515-961-1020 or come in the Auditor's office personally to fill out an absentee ballot request form if you desire a mail in absentee ballot. The deadline to request this mailing is August 14, 2023, by 5:00pm, 53.2 of Iowa Code. The Auditor's office will start mailing absentee ballots to voters approximately August 11, 2023, depending on delivery of the ballots, 53.8 of Iowa Code. Once ballots are mailed to voters, the voted ballot must be returned to the Auditor's office by 8:00pm on election night, with no deficiencies and with complete affidavits, 53.18(2) of Iowa Code. Voters interested with inperson absentee voting will be located at the Administration Building in the Auditor's office, 301 N. Buxton Ste. 101 Indianola, IA 50125. In – person absentee voting will start approximately August 11, 2023, depending on delivery of the ballots, 53.10(1) of Iowa Code. In-person absentee voting will be available during regular business hours, 8:00am to 4:30pm Monday through Friday, except August 14, 2023, whereas voting will stay open until 5:00pm with pre-registration deadline, 48A.9 of Iowa Code.

All polling locations are accessible to all voters including those with disabilities, 49.21(1). Curbside voting is available during in-person absentee and on election day at the voters polling location, 49.90, 49.91 of Iowa Code. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the Warren County Auditor's office at 515-961-1020, IAC 721 –21.50(10).

Voting for in-person absentee or at the polling locations will require proof of identification. Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1. May have the voters identify/residence attested to by another registered voter in the precinct. 2. Prove identity and residence using Election Day registration documents. Or 3. Cast a provisional ballot and provide proof of identity/residence at the Warren County Auditor's office by September 5, 2023, by noon. Election Day Registrant attesters must provide an approved form of identification. 
