**18.01    PURPOSE.**

This ordinance empowers the Board of Supervisors of Warren County, Iowa, to establish speed restrictions on secondary roads and the County Conservation Parkway road system within Warren County.

**18.02    DEFINITIONS.**

For use in this ordinance certain terms or words used herein shall be interpreted or defined as follows:

1. “Secondary Road” means those roads under county jurisdiction.
2. “Board” means the Warren County Board of Supervisors
3. “County Conservation Parkways” means those parkways defined as county conservation parkways under Section 306.3 of the Code of Iowa (2020).

**18.03    AUTHORITY.**

Warren County Board recognizes that the Iowa Code sets speed limits on all roads and streets with respect to surfacing type and use. However, Section 321.285(5) of the Code of Iowa does provide for setting speed limits not listed in the Code.

**18.04    SPECIAL SPEED RESTRICTIONS.**

The Board has determined based on engineering and traffic investigations that the speed limits at the following secondary road locations are greater than is reasonable and proper under the conditions found to exist. The Board therefore determines and declares the reasonable and proper speed limit at the following secondary road locations, effective when appropriate signs giving notice of the speed limits are erected by the Board.

**18.05 SPECIAL 15 MPH SPEED ZONES.**

A speed in excess of fifteen (15) miles per hour shall be unlawful on any of the following designated roads or parts thereof: NONE.

**18.06 SPECIAL 20 MPH SPEED ZONES.**

A speed in excess of twenty (20) miles per hour shall be unlawful on any of the following designated roads or parts thereof: NONE.

**18.07 SPECIAL 25 MPH SPEED ZONES.**

A speed in excess of twenty-five (25) miles per hour shall be unlawful on any of the following designated roads or parts thereof:

1. All of the roads bounded by Clover Hill Drive, County Line Road and State Hwy 5, located in Section 3, T-77N, R-24W.
2. Wright Road/Coolidge Street on the southern city limits of Norwalk, from State Hwy 28 east to the city limits of Norwalk.
3. On Kennedy Street from approximately the N1/4 corner of Section 31-76-23, easterly to the Northeast Corner of said Section 31-76-23.
4. County Line Road, Designated School Zones at McCombs Middle School and Studebaker Elementary School when flashing.
5. All local streets in Churchville in the SE 1/4, SE 1/4, Section 8-7-25.
6. County Hwy R45 from the south corporation line of St. Marys to a point 1450 feet north of County Hwy G50.
7. 113<sup>th</sup> Avenue south of Delaware.

**18.08 SPECIAL 30 MPH SPEED ZONES.**

A speed in excess of thirty (30) miles per hour shall be unlawful on any of the following designated roads or parts thereof:

1. County Line Road, from SW 9<sup>th</sup> Street, west to a point 300' west of SW 11<sup>th</sup> Street.
2. Summerset Road, from 150 feet west of 138<sup>th</sup> Avenue to approximately 1000 feet east of 138<sup>th</sup> Avenue.

3. On NE 24<sup>th</sup> Avenue, in Beech, from near the NW corner, SW 1/4, NE 1/4, Section 23-76-22, thence east approximately .5 mile, terminating near the NE Corner, SE 1/4, NE 1/4, of said Section 23.
4. From SE Corner, SW 1/4, SW 1/4, Section 15-74-23, west to State Hwy 65, near the SW Corner, SE 1/4, SE 1/4, Section 16-74-23 (Liberty Center).
5. On 43<sup>rd</sup> Avenue, in Prole, from State Hwy 28 south to Harding Street.

**18.09 SPECIAL 35 MPH SPEED ZONES.**

A speed in excess of thirty-five (35) miles per hour shall be unlawful on any of the following designated roads or parts thereof:

1. Wright Road/Coolidge Avenue, from city limits of Norwalk east 300 feet.
2. On County Hwy G76, from city limits of Lacona east approximately 533 feet.
3. On County Line Road, between SW 9<sup>th</sup> and SE 14<sup>th</sup> Streets except designated school zones when flashing.
4. On County Hwy R45, from 1270 feet south of Adams Street, thence north to the Polk-Warren County Line, terminating near the NW Corner, Section 3-77-25.
5. 155<sup>th</sup> Avenue, from State Hwy 92, south to Johnson Street, thence east on Johnson Street to 160<sup>th</sup> Avenue.
6. On County Hwy R63, from 0.4 mile north of Hwy 5 to the Polk-Warren County Line.
7. On Clover Hill Drive, from State Hwy 5 north to County Line Road.
8. On Erbe Street from County Hwy S23 to the west 0.4 mile.
9. On Fulton Street, from County Hwy R57 to 73<sup>rd</sup> Avenue.
10. On Adams Street, from County Hwy R45 to the east approximately 0.5 mile.
11. On 30<sup>th</sup> Avenue, from the north corporation line of Cumming to a point approximately 0.55 mile north of County Hwy G14.
12. On County Hwy G14, from the easterly city limits of Norwalk to County Hwy R57.
13. On 85<sup>th</sup> Avenue between County Hwy R57 and Nevada Street.

14. On Jesup Avenue from 70<sup>th</sup> Avenue to County Hwy R57.
15. On County R57 Hwy between Carpenter Street and Beardsley Street.
16. On Fillmore Street west of 73<sup>rd</sup> Avenue.
17. On 73<sup>rd</sup> Avenue between County G24 Hwy and Fulton Street.
18. From 650 feet west of 138<sup>th</sup> Avenue to 285 feet west of 143<sup>rd</sup> Avenue.
19. On Beardsley Street/Border Street between County Hwy R57/80<sup>th</sup> Avenue/SW 28<sup>th</sup> Street and 85<sup>th</sup> Avenue/Fleur Drive.

**18.10 SPECIAL 40 MPH SPEED ZONES.**

A speed in excess of forty (40) miles per hour shall be unlawful on any of the following designated roads or parts thereof:

1. On County Line Road, from SE 14<sup>th</sup> Street to State Hwy 65/69.
2. On Dakota Street, from 113<sup>th</sup> Avenue, east to State Hwy 65/69.
3. On Carpenter Street, from 120<sup>th</sup> Avenue, east to State Hwy 65/69.
4. On 113<sup>th</sup> Avenue, from Dakota Street north to 420 feet north of Cleveland Trail.
5. On Beardsley Street, from County Hwy R63 east to 113<sup>th</sup> Avenue.
6. On Briggs Street, from 150<sup>th</sup> Avenue east to County Hwy G16.
7. On 30<sup>th</sup> Avenue, from Harrison Street, south approximately 1600 feet.
8. On County Hwy S23, from the north corporation line of the City of Milo, north 1000 feet.
9. On Summerset Road, from 0.4 mile east of State Hwy 65/69 to 150 feet west of 138<sup>th</sup> Avenue and from approximately 1000 feet east of 138<sup>th</sup> Avenue to 143<sup>rd</sup> Avenue.
10. On 140<sup>th</sup> Avenue, from near NW Corner, SW1/4, SW 1/4, Section 17-75-23, thence north 0.75 mile, terminating near the NW Corner of said Section 17.

11. On 140<sup>th</sup> Avenue from McKinley Street to 0.2 mile north of McGregor Street.
12. On McGregor Street, from 140<sup>th</sup> Avenue to State Hwy 65/69.
13. On County Hwy G76, from State Hwy 69 to the west 0.30 mile.
14. On 150<sup>th</sup> Avenue/Fairfax Street, from Summerset Road to a point 1,450 feet west of 155<sup>th</sup> Avenue.
15. On 50<sup>th</sup> Avenue, from Clarke Street to Dakota Street.
16. On County Hwy G64, from Interstate 35 east 0.3 mile.
17. On County R63 Hwy 160' north of Inwood Street 1,040 feet south of Inwood Street.
18. On 50<sup>th</sup> Avenue from State Hwy 28, approximately 1.2 miles, to Harding Street.
19. On Gear Street from State Hwy 28, approximately 729', to 50<sup>th</sup> Avenue.
20. On Nevada Street between County R57 Hwy and County R63 Hwy.
21. On 43<sup>rd</sup> Avenue from County 28 Hwy 28 to 220 feet North of Ford Street.
22. On 173<sup>rd</sup> Avenue from County G58 Hwy to ½ miles north.
23. On 90<sup>th</sup> Avenue from 90<sup>th</sup> Lane to State Hwy 92.
24. On 113<sup>th</sup> Ave from Dakota Street North to 420 feet North of Cleveland, extending to Carpenter Street.
25. On Cleveland Street between 170<sup>th</sup> Ave to 178<sup>th</sup> Avenue.
26. On 150<sup>th</sup> Ave between Hwy 92 and G36 Hwy.
27. On Jersey Street from 150<sup>th</sup> Ave to Indianola City Limits.

#### **18.11 SPECIAL 45 MPH SPEED ZONES.**

A speed in excess of forty-five (45) miles per hour shall be unlawful on any of the following designated roads or parts thereof:

1. On Coolidge Street from 300 feet east of the city limits of Norwalk to County Hwy R57.

2. On County Hwy G76, from approximately 533 feet east of the easterly city limits of Lacona to approximately 651 feet east of the easterly city limits of Lacona in Section 22/27-74-22.
3. On County Hwy R45 near the City of St. Marys:
  - a. Commencing at the intersection with County Hwy G50, north a distance of 1,450 feet.
  - b. Commencing approximately 300 feet north of St. James Street at the north corporation line of the City of St. Marys, thence north approximately 800 feet.
4. On County Hwy R57, from the north corporation line of Norwalk to Beardsley Street and from 80<sup>th</sup> Avenue to 85<sup>th</sup> Avenue.
5. On County Hwy R57, from Grimes Street north 0.2 mile.
6. On County Hwy R63, from Hwy 5 north 0.4 mile.
7. On County Hwy G76, from the west corporation line of Lacona to the west 725 feet.
8. On County Hwy G76, near the City of New Virginia, from the south junction of County Hwy R45 west 0.1 mile.
9. On 155<sup>th</sup> Avenue from State Hwy 5 to the Polk County Line.
10. On Beardsley Street, from 50<sup>th</sup> Avenue to the west corporation line of Norwalk.
11. County Hwy R63, approximately 1200' south of County G14 Hwy to Bronze Street.
12. County Hwy S23, 700' north of School Street to 2340' north of School Street.
13. From State Hwy 65/69 to 650 feet west of 138<sup>th</sup> Avenue.
14. From 285 feet west of 143<sup>rd</sup> Avenue to 150<sup>th</sup> Avenue.
15. On Veterans Parkway between the City of West Des Moines Corporate Limits from Interstate 35 east right-of-way boundary to the east approximately 0.75 miles.
16. On County G14 Hwy from 10<sup>th</sup> Avenue (Warren/Madison County line) to the East 6,750 feet.
17. On 20<sup>th</sup> Avenue from Adams Street to the Polk County Line.

18. On Scotch Ridge Road from 185 feet SW of Blazing Star Drive (Carlisle) to 475 feet NE of Blazing Star Drive.
19. On County Hwy G50, starting approximately 1,535 feet East of 10<sup>th</sup> Avenue continuing East approximately 2,495 feet.
20. On County Hwy G14 from Norwalk City limits to County Hwy R63.
21. On 20<sup>th</sup> Ave from Adams Street to the Polk County Line.
22. On County Highway G58 from State Highway 65/69 to 118<sup>th</sup> Avenue.
23. On 110<sup>th</sup> Avenue Between Hoover St. and Grimes Street 45 MPH on County Highway G50 from 10<sup>th</sup> Avenue (Warren and Madison County Line) east approximately 3,948 ft.

#### **18.10 SPECIAL 50 MPH SPEED ZONES.**

A speed in excess of fifty (50) miles per hour shall be unlawful on any of the following designated roads or parts thereof:

- a. Summerset Road from State Hwy 65/69 east 0.4 mile.
- b. Summerset Road From 143<sup>rd</sup> Avenue to 150<sup>th</sup> Avenue.

#### **18.11 PENALTIES.**

Any person found in violation of this ordinance shall be guilty of a simple misdemeanor and subject to a fine as set forth in the current Iowa Code.

#### **18.12 ADDITIONAL AREAS ADDED.**

Throughout the year, at the request of the County Engineer, the Board of Supervisors may add additional areas of road to this ordinance. See the Warren County website for additions to this Ordinance.

#### **18.13 SEVERABILITY CLAUSE.**

If any section, provision, or part of this ordinance shall be adjudged unconstitutional or otherwise invalid, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not invalid or unconstitutional.
